



BUMBRAH CAMP & GLAMP

INDEMNITY, ASSUMPTION OF RISK AND WAIVER OF LIABILITY

IMPORTANT: PLEASE READ THIS DOCUMENT CAREFULLY BEFORE SIGNING.

By entering Bumbrah Camp & Glamp, situated on Krakeelpoort Farm, Bot River, each guest acknowledges that they have read, understood and voluntarily agree to the terms of this Indemnity and Waiver of Liability.

1. ASSUMPTION OF RISK

I acknowledge that camping, glamping and outdoor recreational activities involve inherent risks that cannot be eliminated.

These risks include, but are not limited to:

- Uneven, rocky or slippery terrain
- Steep slopes, embankments and natural obstacles
- Falling branches, trees or natural debris
- Exposure to changing weather conditions, including wind, rain, cold, heat and lightning
- Wildlife including snakes, spiders, insects, bees and other animals
- Braais, hot coals and firewood
- Wood-fired hot tubs and hot water
- Water hazards, drowning and slips around wet surfaces
- Farm roads, vehicles, trailers and agricultural activities
- Hiking, walking and cycling
- Hammocks, cargo nets, climbing nets, swings, ropes, ladders, bridges and any other recreational equipment or structures
- Any other natural or man-made hazards associated with a working farm and outdoor environment.

I fully understand these risks and voluntarily accept them for myself and every member of my booking.

2. USE OF FACILITIES AT OWN RISK

All recreational facilities and equipment provided by Bumbrah Camp & Glamp, including but not limited to hammocks, cargo nets, climbing structures, swings, hot tubs, hiking trails, play areas/swings and any other recreational features, are used entirely at the participant's own risk.

Guests are responsible for ensuring that all equipment is used safely, responsibly and only for its intended purpose.

Guests agree not to misuse, overload, climb beyond designated areas, jump from, or intentionally damage any recreational equipment.

Bumbrah Camp & Glamp accepts no responsibility for injuries arising from the ordinary risks associated with the proper or improper use of these facilities, except where liability cannot legally be excluded under South African law.

3. PERSONAL RESPONSIBILITY

Each guest accepts full responsibility for their own safety and the safety of every person forming part of their booking.

Guests agree to:

- Always exercise reasonable care.
- Follow all safety instructions and signage.
- Use facilities responsibly.
- Avoid activities beyond their physical ability.
- Immediately report any unsafe condition or damaged equipment to management.

4. SUPERVISION OF CHILDREN

Parents or legal guardians remain fully responsible for always supervising all children under the age of 18.

Children may only use recreational facilities under appropriate adult supervision.

Bumbrah Camp & Glamp does not provide child supervision and accepts no responsibility for injuries resulting from inadequate supervision.

5. MEDICAL FITNESS

I confirm that I am medically fit to participate in camping and outdoor recreational activities.

I understand that emergency medical services may take time to reach the property due to its rural location.

Should emergency medical treatment become necessary, I authorise Bumbrah Camp & Glamp to obtain reasonable medical assistance on my behalf. All medical costs remain my own responsibility.

6. RELEASE AND INDEMNITY

To the fullest extent permitted by South African law, I release, indemnify and hold harmless:

- The owners
- Krakeelpoort Farm
- Directors

- Employees
- Managers
- Contractors
- Agents
- Representatives

from any claims, demands, actions, losses, damages, costs or expenses arising directly or indirectly from my visit to the property, including but not limited to:

- Personal injury
- Illness
- Death
- Loss of income
- Emotional distress
- Damage to or loss of personal property
- Theft
- Vehicle damage
- Caravan or camping equipment damage

except where liability cannot legally be excluded under South African law.

7. DAMAGE TO PROPERTY

I accept responsibility for any loss or damage caused by myself, members of my booking or my guests to:

- Buildings
- Campsites
- Bathrooms
- Furniture
- Hot tubs
- Hammocks
- Cargo nets
- Recreational facilities
- Landscaping
- Equipment
- Any other property belonging to Bumbrah Camp & Glamp or Krakeelpoort Farm.

I understand that repair or replacement costs may be deducted from my breakage deposit and that I remain liable for any additional costs exceeding the deposit.

8. PERSONAL PROPERTY

All personal belongings, vehicles, caravans, trailers, camping equipment and valuables are brought onto the property entirely at the owner's risk.

Bumbrah Camp & Glamp accepts no responsibility for theft, loss or damage.

9. CAMP RULES

I confirm that I have received, read and agree to comply with all Bumbrah Camp & Glamp Rules.

Failure to comply with the camp rules or safety instructions may result in immediate removal from the property without refund.

10. PHOTOGRAPHY

I acknowledge that photographs or videos may occasionally be taken for promotional purposes.

Should I not wish to appear in any promotional material, I will notify management in writing before my arrival.

11. SEVERABILITY

Should any provision of this agreement be declared invalid or unenforceable, the remaining provisions shall remain in full force and effect.

12. GOVERNING LAW

This agreement shall be governed by and interpreted in accordance with the laws of the Republic of South Africa.
